Correction of Appendix 3Bs released on 25 October 2019

Clime Capital Limited (**Company**) advises that it has come to its attention that there has been an error in each of the Appendix 3Bs released on 25 October 2019.

The first Appendix 3B released incorrectly stated that 1,089,168 fully paid ordinary shares in the Company and 353,546 convertible notes, had been issued by the Company as a result of the compulsory acquisition of the outstanding shares in CBG Capital Limited (**CBG**) following the close of the Company's takeover offer for CBG. In fact, only 758,771 fully paid ordinary shares in the Company and 246,297 convertible notes were issued by the Company. As a result, the Appendix 3B also included an incorrect number of securities quoted on the ASX following the issue of these securities.

The second Appendix 3B released included an incorrect number for the number of securities quoted on ASX as it followed the first Appendix 3B released.

Attached are corrected Appendix 3Bs.




